I, Property Owner of the above referenced lot, do hereby register the following vehicle, which is owned by the Property Owner or a Registered Resident, to be used in the Hide-A-Way Lake Community. Property Owner Information Report must be up-to-date and signed by Property Owner.

- All vehicles in either lane must come to a complete stop when approaching the main gate. This is for your safety. The gate will only allow **one gate arm** to open at a time. The vehicle with the automatic tag must completely stop for reader to activate. Stop at the stop sign located in the center of entry lanes.
- Current vehicle insurance showing the VIN number of the vehicle must be provided along with the property owner/other occupant driver's license (both copied for HAWL Office file). I further understand that vehicle insurance must be maintained consistently for this vehicle. A copy of the vehicle registration form is not needed; however, information which must be provided includes license plate number, body style, make, model, year, color, and vehicle serial number (VIN). **All information must be provided prior to the Automatic Tag/Decal purchase.**
- I understand that whenever a car decal is replaced, the vehicle is sold, or I move from Hide-A-Way Lake, both the HAWL Decal and the Automatic Decal must be removed from the vehicle and turned into the HAWL Office.
- This vehicle will be operated only by a properly licensed person, in a lawful manner, and in accordance with the rules set down by the Hide-A-Way Lake Club, Inc. I agree to assume full financial responsibility for any and all damages or injury resulting from the operation of the described vehicle while within the Hide-A-Way Lake Community. I also understand that any penalties which may be assessed for traffic/rules violations will be charged to my account. **PROPERTY OWNERS ARE RESPONSIBLE FOR ALL ACTIONS OF THEIR OTHER OCCUPANTS/REGISTERED RESIDENTS.**
- The Automatic Tag with Decal is the property of Hide-A-Way Lake Club, Inc. and is non-transferable, for any reason. Hide-A-Way Lake Office is authorized to verify any information submitted and if any false statement is made or if the tag is placed on any vehicle other than the registered vehicle, the Property Owner will lose the automatic gate privilege to enter the community and will pay an administrative fine.
- Placement of Automatic Tag - Tag is to be placed on **inside top passenger side of windshield (opposite side of decal) below any strips of window tint and from any antenna in the windshield. Proper placement is the responsibility of the property owner. Any misplacement will result in having to purchase a new decal at full price.** HAWL decal is to be placed on the **inside driver side of windshield above state inspection sticker.** REMOVE ALL OTHER EXPIRED HAWL DECALS. A picture showing proper placement is available in the HAWL Office.
- Property owners and residents who have an automatic tag with decal must be a member in good standing with the club for the tag to stay activated. The automatic tag can be deactivated for outstanding issues. Those violators will have to use the visitor lane.
- Property owners are responsible for notifying the HAWL office of any changes regarding pertinent information (i.e. phone numbers, residents, registered vehicles and boats, etc.).

Please note: The HAWL office must activate the automated tags in the computer system before it will work. This will be completed by the close of business on the next business day.
