The Chair entertained a motion to approve the Minutes of the Board meeting of March 8, 2023. Kathy Busco acknowledged the motion, Tom Gibilterra seconded the motion. Unanimously approved.

MANAGER'S REPORT - Bruce Devillier

- 1. The water system loan through CoBank Qualified Patronage Distribution for 2022 cash distribution is \$2,924.39. 2022 equity patronage is \$1,462.20 for a year-end 2022 equity balance of \$3,317.99, which includes the \$1,000 set-up fee with CoBank.
- 2. The 2023 Road Overlay Project with Lowe Bros. LLC was completed on March 31, 2023. The total capital improvement cost was \$491,709.
- 3. The 2023 Road Striping Project with Lane Line, LLC was completed on April 1, 2023. The total capital improvement cost was \$22,800.
- 4. The contract for resurfacing the tennis courts and adding pickleball courts has been signed with Magnolia Sports Construction. The total capital improvement cost is \$19,000. This project is scheduled to be completed this month.

- 5. The replacement gate operators with all new safety equipment and sensors for the Main Gate and Southgate through AVL Installations is in works and is scheduled for completion this month. The total capital plan cost is \$17,333.67.
- 6. The Gate Sentry Visitor Management software was renewed last month. The total capital improvement cost is \$6,825.
- 7. The water system generators at Well #3 and Well #4 were repaired by Taylor Power Systems. The total capital improvement cost was \$2,086.12.
- 8. The Mississippi Public Utility Regulatory Tax Gross Revenue Report was completed last month through CPA Kent Whitfield.
- 9. Beginning this week, Davey Tree Service will be trimming tree limbs from Coast Electric's powerlines throughout our community. This is a very important process to maintain our powerlines. This is planned to take place over the next four to six weeks.
- 10. Red boat and golf cart decals for the 2023/2024 season are on sale now. The orange decals expire on April 30, 2023.
- 11. On March 3, 2023, a civil case has been filed in Chancery Court of Pearl River County on Hide-A-Way Lake, Inc., the "developer" of our community, for ownership of 40 acres tract of land by the back spillway that <u>belongs</u> to our community. We are working with the US Army Corps of Engineers Mississippi branch to have a jurisdictional determination/permit of wetlands for this 40 acres tract.
- 12. The permit with the U.S. Fish and Wildlife Service for Canadian Goose Nest and Egg Depredation is in works. The registration number is RG-04840A. As of April 4, 2023, there have been 23 eggs and 4 nests.
- 13. Pool lifeguard staffing is currently in works. A lifeguard class is scheduled with SELA Aquatics on April 29th and 30th with an online portion scheduled for April 26th. The pool opens for Resident Swim on April 18, 2023, and opens with lifeguards on May 20, 2023.
- 14. All insurance policies are being reviewed with Eagan Insurance for the renewal period of April 30, 2023, through April 30, 2024.
- 15. The following is a report of our delinquent accounts as of March 25, 2023:
