The Security Contractor's Report for May 2023 was presented by James Stone, of Veteran Security Services.

The Chair entertained a motion to waive the reading of the Minutes of the Board meeting of May 10, 2023. Tom Gibilterra acknowledged the motion, Elizabeth Ennis seconded the motion. Unanimously approved.

The Chair entertained a motion to approve the Minutes of the Board meeting of May 10, 2023. Kathy Busco acknowledged the motion, Jim Wells seconded the motion. Unanimously approved.

MANAGER'S REPORT - Bruce Devillier

- 1. The contract for resurfacing the tennis courts and adding pickleball courts was completed last month. The total capital improvement cost of \$19,000.00 was paid to Magnolia Sports Construction.
- 2. The capital purchase of chlorine equipment, which consisted of two regulators and one switchover, for the water system was purchased through Coast Chlorinator for a total cost of\$2,880.98.
- 3. The capital purchase of a generator circuit board replacement for Well #4's generator was purchased through Taylor Sudden Services for \$1,555.00.
- 4. The Capital Expenditure Plan for 2024 and our Ten Year Capital Expenditure Plan are in the planning stages with the Finance Committee and HAWL Staff. These will be presented to the Board of Directors next month.
- 5. Extra security patrol shifts and details with the Pearl River County Sherriff Office have been scheduled for the summer season. As a reminder, traffic violation fines are doubled during the

- months of June and July as part of our campaign "Keep Kids Alive Drive 25" as we are trying to get everyone to focus on safety on our roadways.
- 6. The permit with the U.S. Fish and Wildlife Services for Canadian geese nest and egg depredation is completed for this year. Permit number RG-04840A was closed with 5 nests and 30 eggs.
- 7. A big "THANK YOU!" to the Friday Men's Club for the American flags placed at the entrance of the community.
- 8. Hide-A-Way Lake's Annual Fireworks Celebration is scheduled for Monday, July 3, 2023, with a rain date of Tuesday, July 4, 2023. In order for the Firework's Celebration to proceed, there must be dry weather conditions at 7:00 pm. This fireworks show depends solely on the donations from Property Owners and is 100% funded through donations. The donation goal is \$7,500. As of June 12, 2023, the donation total was \$3,976.00, which includes \$315.00 carried over from the 2022 donations.
- 9. The next Community Meet and Greet with the General Manager is on Saturday, June 24, 2023, at 9:30 am in Waters Edge Restaurant (upstairs of the Lodge). This face-to-face collaboration with property owners will provide the opportunity to ask questions to the General Manager directly. This is a great time to ask any questions to prevent the spread of misinformation and to meet some of your neighbors as great neighbors make great communities. While new property owners are highly encouraged to attend, everyone in HAWL is welcome. This meeting will also provide the opportunity to meet the candidates running for the Board of Directors.
- 10. The Sunset on the Beach event featuring Rock Kandy that took place on Friday, May 26, 2023, was a huge success. This event was sponsored by TCI Trucking. If you missed this fun event, two more events are scheduled in the future: Friday, June 30, 2023, featuring Runaway Train sponsored by Triton Stone and Friday, August 4, 2023, featuring Runaway Train sponsored by The Scholarship Foundation for Hide-A-Way Lake Students. A big "THANK YOU!" to the sponsors of these events.
- 11. On March 3, 2023, a civil case was filed in Chancery Court of Pearl River County on Hide-A-Way Lake, Inc., the "developer" of our community, for ownership of 40 acres tract of land by the back spillway that belongs to our community. Working with the developer's attorney, we have agreed to hire Wetland Consulting Services, Inc. for wetland determination and designation. The fee of \$5,900.00 will be split between both parties. Of the 40 acres, approximately 21 acres are wetlands.
- 12. The Public Service Commission Annual Report is completed with Kent Whitfield's CPA Firm. Our water rate review is scheduled this month with Mississippi Rural Water Association.
- 13. Bryan Blackwell is now our water system operator that is on record with the MSDH.
- 14. The Property Owners Association Nominating Meeting for the two seats on the Board of Directors was held on June 3, 2023. The following resumes were received: Alice Button, Tom Gibilterra, John Pigott, and Stephen Strausbaugh. Election ballots will be mailed on June 27, 2023, and the election will be held on July 15, 2023.
